The meeting will be held on Thursday, June 20, 2024, at 6:30 p.m.

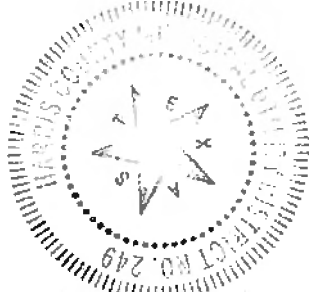
The Board shall consider and discuss the following matters and take any action necessary and appropriate with respect to such matters:

1. Public comments;
2. Approval of the minutes of the May 16, 2024, Board meeting;
3. District security matters, including approval of Interlocal Agreement for Law Enforcement Services between Harris County and the District;
4. Tax Assessor-Collector's Report, including authorizing the payment of invoices presented;
5. Delinquent Tax Report, including discussion of any legal action taken by the District's delinquent tax collections attorney;
6. Bookkeeper's Report, including:
 - a. Financial and investment reports, and authorizing the payment of invoices presented;
 - b. Discussion regarding fraudulent activity regarding a District check that was improperly cashed; and
 - c. Discussion regarding request from Harris County Sheriff's Office related to prior District payments for security services;
7. Discussion regarding landscaping and maintenance within the District;
8. Storm Water Management Program Report;
9. Engineer's Report, including:
 - a. Authorizing the design and/or advertisement for bids for the construction of facilities within the District, and approving of related storm water plans, including:
 - (i) Review and approval of any Storm Water Pollution Prevention Plans or Storm Water Quality Management Plans related to construction within or on behalf of District, and the execution of any documentation in connection therewith;
 - (ii) Water Well No. 2;
 - (iii) Wastewater Treatment Plant Bar Screen Improvements; and

- (iv) Wastewater Treatment Plant Permanent Restroom Facilities;
 - b. Authorizing the award of construction contracts or concurrence of award of contracts for the construction of facilities within the District, approval of any related storm water permits and acceptance of TEC Form 1295;
 - c. Status of construction of facilities to serve land within the District, including the approval of any pay estimates and/or change orders;
 - d. Status of Storm Water Quality Permits, and the taking of any action in connection therewith; and
 - e. Discussion regarding regional detention project with Harris County Water Control and Improvement District No. 110;
10. Operator's Report, including:
- a. Monthly Report;
 - b. Appeals of District charges;
 - c. Status of compliance with District's waste discharge permit;
 - d. Authorizing the repair and maintenance of District facilities, and the taking of any action in connection therewith; and
 - e. Refer accounts for collection;
 - f. Submission of updated contact information and/or descriptive information regarding District facilities that qualify for critical load status to the County Office of Emergency Management, Public Utility Commission, and the Division of Emergency Management of the Governor, relative to compliance with §13.1396, Texas Water Code;
11. Communications Report/Website updates;
12. Approval and execution of Representation Agreement by and between the District and The J. Beard Real Estate Company, LP;
13. Attorney's report, including:
- a. Review of Annual Maintenance for Arbitrage Analysis Report prepared by Municipal Risk Management Group, L.L.C.;
14. Authorize completion, execution and filing with the Secretary of State of Voting System Annual Filing Form relative to District elections;
15. Discussion regarding utility capacity requests, including request from Harris County Emergency Services District No. 7 in connection with the development and possible annexation of a 63-acre tract of land, including:
- a. Interlocal Development, Financing and Annexation Agreement;
 - b. Petition for Addition of Land to the District; and
 - c. Petition for Consent to Annex Land;
16. Closed Session pursuant to Texas Government Code, Section 551.071 (consultation with attorney regarding matters protected by attorney-client privilege) and/or Section 551.072 (deliberation regarding acquisition of interest in real property);

17. Reconvene in Open Session and authorize any action(s) necessary in connection with matters addressed in closed session; and
18. Matters for possible placement on future agendas.
